RESOLUTION 08-26, 2<sup>nd</sup> Reading of Resolution Authorizing Creation of Paid Position of Career Lieutenant- A reading of resolution 08-26, Authorizing Creation of Paid Position of Career Lieutenant, was conducted by Chairman Sirolli. At the closing of the reading, a motion was made by Treasurer Pantalone to approve the resolution. The motion was seconded by Commissioner Gallo and the roll call vote was unanimous and in the affirmative.

RESOLUTION 08-31, Authorizing Hiring of Provisional Career Lieutenants- A motion was made by Treasurer Pantalone and seconded by Commissioner Gallo to approve the resolution to hire three (3) Provisional Career Lieutenants. The three (3) Lieutenants were listed as Rich Petkevis, Mario Scullan, and Paul Sickler. The roll call vote was unanimous and the affirmative.
