Long Range Planning Committee- Chairman Sirolli announced that a long range planning committee was established in the past without any progress made. He then requested the help from a commissioner to head this committee. Commissioner Gallo volunteered to handle the project. It was noted that Mt. Laurel Fire Department is sending a copy of their plan to use as an example. Chairman Sirolli asked that Commissioner Gallo provide a report to the Board in 30 days.

Municipal Meeting at Town Hall- It was announced that a meeting will be held on March 11th at 7:30 p.m. to entertain a hearing and resolution to reduce the Fire District budget that was defeated. The hearing will reflect that the fire district budget being reduced in the amount of \$28,500. A small discussion was held on the budget being reduced, resulting in a tax increase in the amount of \$2.00 per year., and the fire district staying under the 4% budget cap.
