NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the Fire District of Winslow Township on **Wednesday, March 13, 2024 at 10:00 AM**, prevailing time, at the Winslow Township Fire District Administrative Office, 9 Cedar Brook Road, Sicklerville, NJ 08081, at which time and place bids will be opened and read in public for:

SPECIFICATIONS TO PROVIDE CARPENTRY SERVICES AT VARIOUS FIRE DISTRICT OWNED BUILDINGS ON AN AS NEEDED BASIS

Specifications, instructions to bidders, and proposal forms may be obtained at the office of the Business Manager during normal business hours. Bids will be made on the proposal form provided in the manner designated therein and required by the specifications enclosed in a sealed envelope and addressed to the Winslow Township Fire District Administrative Office, 9 Cedar Brook Road, Sicklerville, NJ 08081, and clearly marked on the outside “date, time and name of the item being bid”.

Surety in the form of a bid bond, certified check or cashier’s check in the amount of 10% of the bid, but not to exceed \$20,000.00 made payable to the treasurer **will not be** required with this bid. A performance bond in the amount of 100% **will not be** required of the successful bidder.

The bid must be accompanied by a Non-Collusion Affidavit. Public Disclosure, Chapter 33 of the Public Laws of 1977 provides that no corporation or partnership shall be awarded any State, County, Municipal or School District contract for the performance of any work or the furnishing of any materials or supplies, unless, prior to the receipt of the bid or accompanying the bid of said corporation or partnership there is submitted a statement. The statement shall set forth the names and addresses of all stockholders in the corporation or partnership who own 10% or more of its stock or any class, or of all individual partners in the partnership who own a 10% or greater interest.

FAILURE TO SUPPLY THIS INFORMATION WITH YOUR FORM OF PROPOSAL WILL BE CAUSE TO REJECT THE BID. The Purchasing Agent or Board of Fire District Commissioners reserve the right to reject any or all bids or to waive any informality in the proposal received and to accept the bid which in their judgment will best serve the interest of the Winslow Township Fire District. Bidders are required to comply with the requirements of N.J.S.A.10:5-31 et seq. and N.J.A.C. 17:27 laws against discrimination because of race, religion, sex, color, etc.

All bidders are hereby notified that, compliance with the New Jersey Prevailing Wage Act that are applicable to this project will be required of any contract awarded.
